Course Title	Course Description
Aviation & Cannabis	<p>With the legalization of recreational cannabis in Canada arrived in October 2018, we are in the early stages of seeing how to manage potentially more substance abuse issues in the workplace.</p> <p>Commonly, workplace policy and procedure development help prepare for this change. However, questions involving clinical treatment and health management arise once substance use actually shows up in your workplace.</p> <p>With a focus on aviation employees, this presentation will highlight details of the presence and impairment issues associated with cannabis (compared with alcohol). We'll also discuss how to manage these situations – before they happen, and what to do when presence/impairment shows up at work.</p>

Certification 101 for Buyers	This presentation will focus on deciphering AC571-024 and determining what type of certification is applicable to the part. This presentation will hopefully provide some tips for those new to Purchasing and give some guidance on why paperwork is so important.
